

SPECIAL TEMPORARY ENROLMENT SCHEME: Tai Tapu School

This scheme commences on 29 May 2013.

Home zone

All students who live within the home zone **described below** (and *shown on the attached map*) shall be entitled to enrol at the school.

The Tai Tapu Primary School Zone is defined as follows:

The area within the below boundary, including both sides of boundary roads,

The north side of the school zone commences at the east end of Early Valley Road and goes west along Early Valley Road then south along Old Tai Tapu Road, west along Osterholts Road then south on Highway 75 to Tancreds Road.

West along Tancreds Road, then south on Ellesmere Road to Collins Road East. From this point west to Collins Road.

West along Collins Road then south on Springs Road to McDonald Road.

East on McDonald Road then south on Englishs Road to Carters Road.

West on Carters Road then south west on Wolfes Road to the end of Wolfes Road at Lake Ellesmere.

East along the bank of Lake Ellesmere to the Halswell river canal outlet.

North up the Halswell River Canal to Ridge Road.

East along Ridge Road to Seabridge Road taking in Motukarara and along State Highway 75 to Prices Valley Road. Along to the north east end of Prices Valley Road. From the end of Prices Valley Road, directly across to the north east end of Kaituna Valley Road, to the north east end of McQueens Valley Road, then to the intersection of Gebbies Pass Road and Summit Road.

North along the Summit Road to Kennedys Bush Road, than west to the eastern end of Early Valley Road.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Former Greenpark School students

Students enrolled at Greenpark School on the date the Minister announced the closure of Greenpark School may be enrolled at Tai Tapu School, regardless of whether they live within the enrolment scheme home zone described above. Enrolments made under this part of special temporary enrolment scheme must occur either during 2013 or for the start of 2014 school year. This provision will also apply to siblings (not yet at school) of eligible students.

Special programmes

Out of zone enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

- **First priority** This priority category is not applicable at this school because the school does not run a special programme approved by the Secretary.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
